ORIGINAL SPANISH COLONIAL HOME

Planned as the first of a Doheny family retreat enclave; project ended after 5 homes following the tragic passing of their son

Preceded the famous Doheny House by 3 years

Site was likely selected for the large peppertree adjacent to the home

Hand-troweled plaster walls embedded with straw (historical anti-crack technique)

Former courtyard was converted to a dining room, maintaining the original fireplace

Custom felt-covered doors with nailhead trim (British country house style)

Kitchen inspired by classic English design

Marbleized painted finishes on columns and floors, purposefully naïve in style

Antique 18th- and 19th-century windows and doors installed throughout. One original window remains (the large arched window) with added French Gothic framing.

Expanded Model T garage now serves as a bedroom and full bath

MAIN HOUSE

15th-century front door and antique French terracotta tile entry

Purposeful architectural sequence: The home's entry is designed as a cozy, intimate space to create a sense of compression and welcome. Upon entry, guests are drawn into the dramatic living room where natural light, soaring 24-foot ceilings, and expansive views of the garden offer a striking visual reveal

Architectural folly: Anchoring the living space, the folly features a cruciform (cross-shaped) floor plan crowned by a pyramidal roof — a focal point that evokes historic European design traditions while providing spatial and visual symmetry

Late 18th-century antique metal windows with wavey glass

Antique Cremone bolts on all doors and windows

19th-century pine flooring with exceptionally wide and long boards

Antique Trumeau mirror above fireplace with custom aerial painting of the estate

1958 O'Keefe & Merritt vintage stove

19th-century English ironstone sink (Downton Abbey-style)

18th-century French tile counters

Calacatta Cielo marble with 16th-century Portuguese tile backsplash

Integrated appliances and custom cabinetry

Custom butler's pantry with distressed antique-style finishes

Dining room created from former bedroom, with China cabinets flanking the central window

Wood floors painted to resemble marquetry/parquetry

Gold leaf-gilded moldings and wall panels, distressed for aged appearance

Bathroom with hand-painted walls inspired by the first Oriental wallpaper imported to Europe for the Stockholm Royal Theater

Hand-forged stair railing mimics draped rope

Antique and vintage light fixtures throughout

Thoughtful window placement designed to capture curated garden views

Original 9-room garden layout by Florence Yoch (landscape designer of Tara's Garden in "Gone with the Wind")

Garden design emphasizes layered views, symmetry, and sightline preservation

100+ year-old cassia and pepper trees anchor the property

Garden rooms inspired by classical English designs with hedge-lined paths

Gothic finch aviary outside the dining room

French Gothic church spire repurposed as fountain with koi-filled deep well

Custom finials aligned with architectural features to create visual harmony

Outdoor living spaces include:

Private pool and outdoor bar

Summer Tea House

Multiple al fresco dining areas and garden vignettes

Fruit trees, custom fountains and aviaries

Exterior walkways and garden paths designed with perspective illusions to enhance scale
