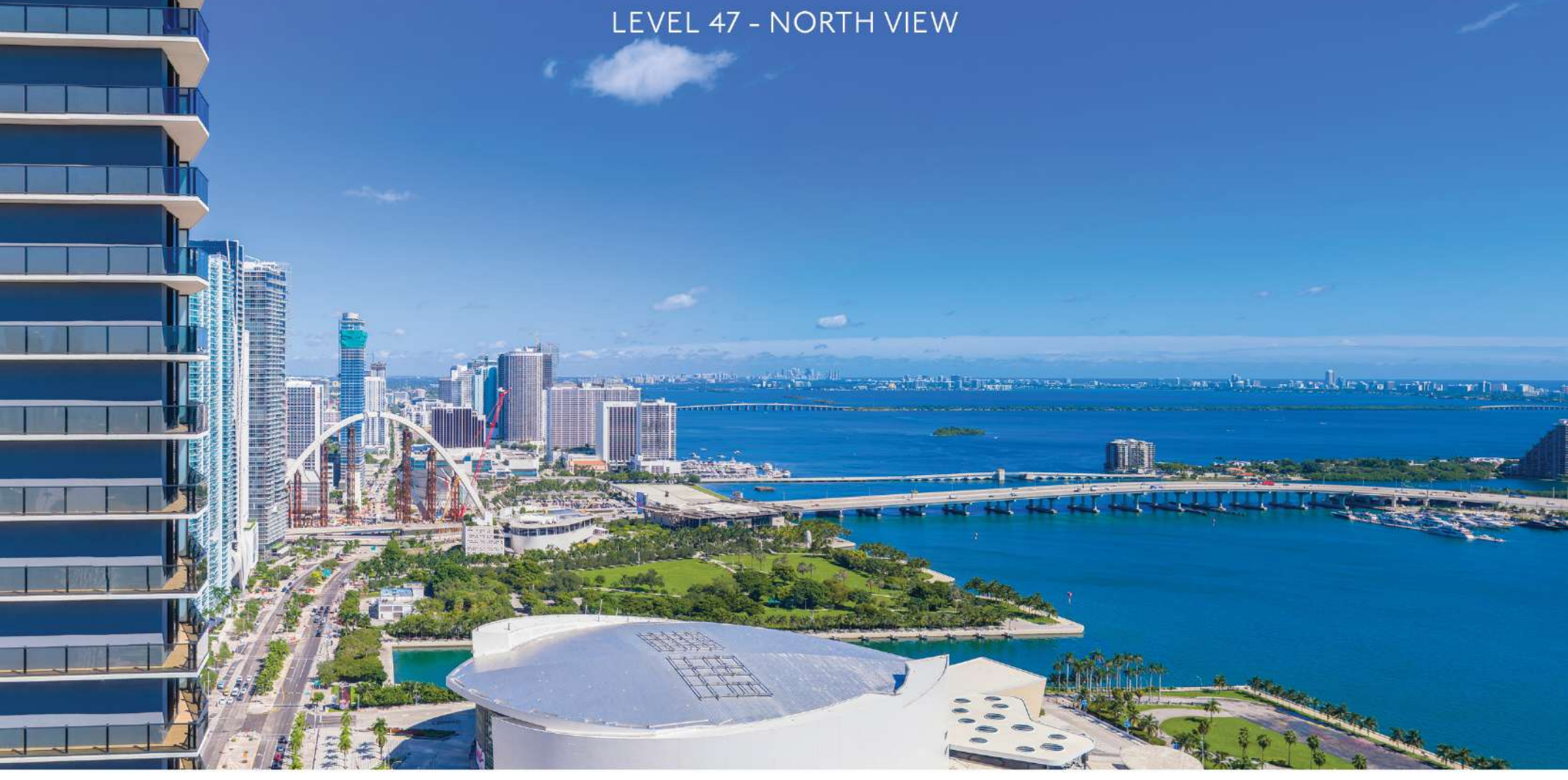

LEVEL 47 - NORTH VIEW

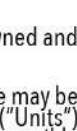
