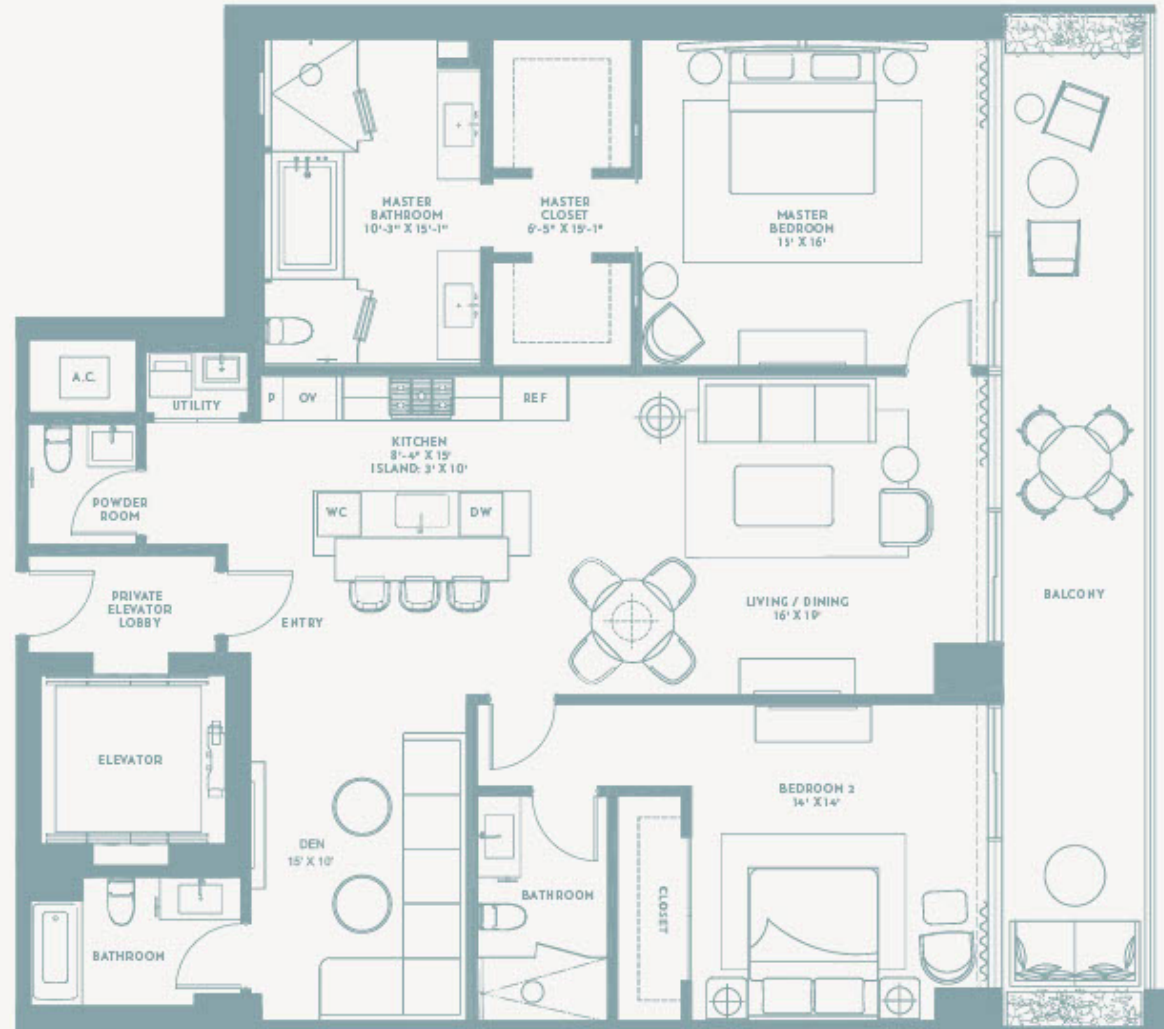
# Model 205 FLOORPLAN
