- (Doors) Many of the doors are original to the house and have typical wear and tear. The door knob is missing on one bedroom door. The sunroom door has minor wood rot on the threshold.
- (Driveways) Some cracks evident in the upper section of the driveway (we replaced the bottom half of the driveway in 2014).
- (Exterior Walls) Typical wear and tear but in good condition. Specific areas of mortar may need re-painting over time given age.
- (Foundation/Slabs) Most of the house is pier and beam. The pier and beam foundation is in good working condition and received adjustments in 2022 but the foundation is original to the house. The settling is consistent with other homes in the area.
- (Interior Walls) Typical wear (picture hanging holes) but otherwise in good condition.
- (Roof) Roof has no known leaks but is reported to have been installed in 2006 and will eventually need to be re-shingled over the next several years.
- (Walls/Fences) Fence to the east is functional but a center post is leaning.
- (Windows) Original windows throughout the majority of the house. The windows are in good working order but two pains have minor cracks, and specific windows may have signs of rot on window sills or frames (e.g. the guest bedroom across from the bathroom on second floor).

(Abestos Components) We were told when we bought the house in 2013 that the exterior panels/shingles on the top exterior above the patio and primary bedroom (exterior) have asbestos components.
 (Lead Based Paint) The house was built in 1940 and therefore comes with the standard lead-based paint addendum.
 (Previous Foundation Repair) A majority of the house is pier and beam. Minor adjustments were made in 2022.
 (Settling) Early in our ownership we saw typical signs of minor settling which led to our pier and beam maintenance in 2022 - we have not experienced any additional signs of settling.
 (Wood Rot) The house is mostly masonry, the house was painted in 2023, but specific/minor areas of wood rot could exist.

*A single blockable main drain may cause a suction entrapment hazard for an individual.
