# 60 Days Before Moving:

### Housing:

- □ Finalize home purchase
- □ Schedule movers or rent moving truck
- □ Research temporary housing if needed
- ☐ Change address with USPS
- □ Transfer/set up utilities in Texas

#### Financial:

- □ Open bank accounts in Texas (if desired)
- Research auto insurance (Texas rates differ)
- □ Update homeowners/renters insurance
- □ Budget for moving expenses

### Legal & Administrative:

• Research Texas driver's license requirements (must get within 90 days)
