As Filed in Book 384 Page 132, records of Madison County, Montana:
On page 3, Section 1 (Architectural Control), Number 8 (Size and Height):
Any auxillary structure shall contain 1000 square feet of enclosed living space
shall be ammended to 500 square feet of living space.

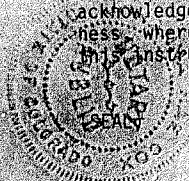
Addition to Covenants:

A guest house may be constructed as temporary quarters (minimum 500 square feet),
as long as the primary residence is completed no later than seven years after the
completion of the guest quarters. The guest quarters and primary residence must
be of similar architectural design and materials, and must meet the same criteria
as the primary residence. Guest quarters may not be located more than 100 feet
from the primary residence.
