^A 10-Year Option

Refers to the Golf and/or Tennis & Pickleball portion of the Membership, and provides the ability to convert to year-to-year participation after the 10-year period expires. Conversion fee for a Golf Membership is \$ 5,000 and for a Tennis & Pickleball Membership is \$ 1,250.

3-Year Financing

Interest-free financing for the Membership capital contribution is available to new Polo Members only. 50% of the Membership fee is due at closing, 25% is due one year later, and the remaining 25% is due two years after closing. Excludes PPO's.

B PPO Rate

The Prior Polo Owner rate applies to current and former Members who have sold their Polo primary residence and purchase a Polo property within 18 months of the sale of their prior Polo home.

Legacy I

25% discount off capital contribution, applicable only to children, step-children, or grandchildren of current Polo Members.^C

Legacy II

\$0 capital contribution, eligible only on Memberships bequeathed to children, step-children, or grandchildren via trust, will, or quitclaim deed, either during one's lifetime or upon a Members' death.

^c In the event that the Transferor has no current children, step-children or grandchildren, they will be permitted to make a one-time Legacy Transfer to a bloodline niece or nephew. Any one who becomes a Member as a result of a Legacy Transfer, is not entitled to make a subsequest Legacy Transfer.
