The first 50 meters of all Costa Rican coastlines are public. The next 150 is designated PNE land. In Costa Rica, PNE land refers to Patrimonio Natural del Estado, which translates to "Natural Heritage of the State." This classification applies to areas that are protected by law and considered vital to the country's environmental conservation efforts. PNE land often includes forests, wetlands, wildlife habitats, and other ecologically significant areas. Here are some key points about PNE land:

- PNE land is owned by the government of Costa Rica and cannot be privately owned. The connecting land owner is considered the conservator. It is managed under strict environmental regulations to ensure its conservation. Activities such as construction, deforestation, or commercial development are typically prohibited but sustainable practices, such as eco-tourism or scientific research, may be allowed under specific conditions and with government approval. Having a wildlife and nature corridor is considered a positive attribute to landowners.
- PNE land plays a critical role in maintaining biodiversity and protecting watersheds.
- The PNE designation is increasingly popular among landowners and developers, as it protects the first 200 meters of coastline while removing the need for planning and permitting oversight from the local municipality. Developers appreciate the added value of ensuring no businesses operate within this zone, preserving its integrity and appeal.


