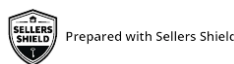

(Ceilings) We noticed a drip in the hallway ceiling when raining, a few years ago but haven't noticed any more dripping or leaking since. It does have a little bit of discoloration around the vent where it used to leak.
 (Doors) The back door needs the doorknob to be set right or replaced but closes and locks
 (Floors) There is some chips and bubbling in the flooring in the kitchen.
 (Interior Walls) There is a small area in the kitchen where we replaced broken Sheetrock but did not texture and paint it. There is some ripped wall paper in the hallway and some pieces of trim broken throughout the house.
 (Roof) The only issue with the roof that we know of is that a while ago there was a slow leak of water from a vent in the hallway when raining but for a couple years now we haven't noticed the leak anymore. So not exactly sure.
 (Walls/Fences) As for fencing the front yard fencing is pretty new, it was done about 2 years ago and has no issues. The back fencing, the side by the ditch was redone and fixed about 5 years ago, no known issues on that side. However the back fencing on the back wall needs to be redone but is still up and standing and the other side needs to be redone but is also still standing and working and the gate from the back to the front yard needs to be fixed.

"500-year floodplain" means any area of land that: (A) is identified on the flood insurance rate map as a moderate flood hazard area, which is designated on the map as Zone X (shaded); and (B) has a two-tenths of one percent annual chance of flooding, which is



considered to be a moderate risk of flooding.

"Flood pool" means the area adjacent to a reservoir that lies above the normal maximum operating level of the reservoir and that is subject to controlled inundation under the management of the United States Army Corps of Engineers.

"Flood insurance rate map" means the most recent flood hazard map published by the Federal Emergency Management Agency under the National Flood Insurance Act of 1968 (42 U.S.C. Section 4001 et seq.).

"Floodway" means an area that is identified on the flood insurance rate map as a regulatory floodway, which includes the channel of a river or other watercourse and the adjacent land areas that must be reserved for the discharge of a base flood, also referred to as a 100-year flood, without cumulatively increasing the water surface elevation more than a designated height.

"Reservoir" means a water impoundment project operated by the United States Army Corps of Engineers that is intended to retain water or delay the runoff of water in a designated surface area of land.
