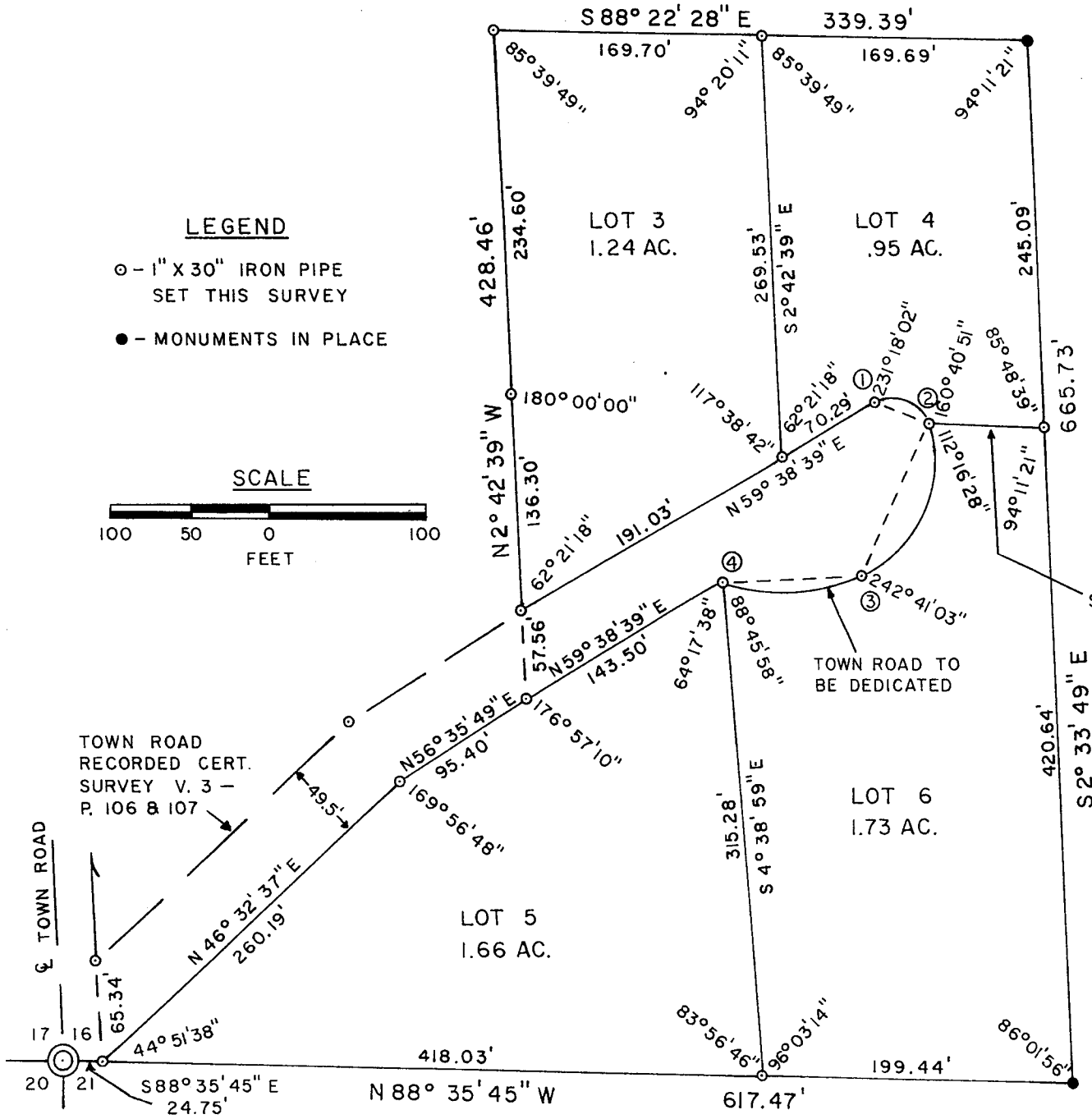

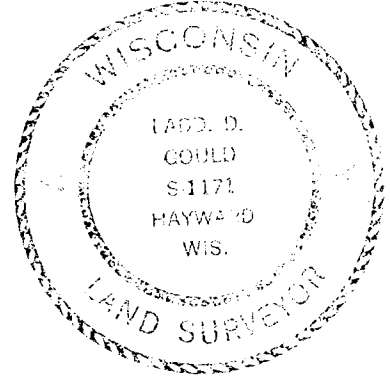


SECTION CORNER

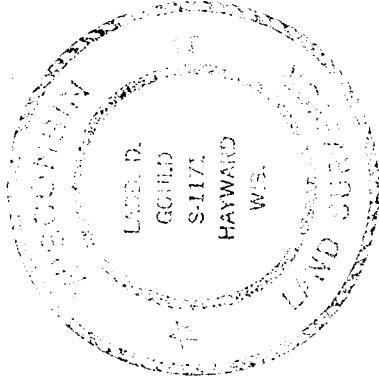
I, Ladd D. Gould, Registered Land Surveyor, do hereby certify:

That I have surveyed, divided and mapped part of the SW $\frac{1}{4}$ -SW $\frac{1}{4}$, Section 16, T 43 N, R 7 W, Town of Cable, Bayfield County, Wisconsin, bounded and described as follows:

Commencing at a brass capped iron pipe marking the Southwest Section Corner of Section 16, T 43 N, R 7 W; thence S 88° 35' 45" E, 24.75 feet to a 1 inch iron pipe and the Point of Beginning; thence N 46° 32' 37" E, 260.19 feet to a 1 inch iron pipe; thence N 56° 35' 49" E, 95.40 feet to a 1 inch iron pipe; thence N 2° 42' 39" W, 428.46 feet to a 1 inch iron pipe; thence S 88° 22' 28" E, 339.39 feet to a 1 $\frac{1}{4}$ inch iron pipe; thence S 2° 33' 49" E, 665.73 feet to a T-shaped iron bar; thence N 88° 35' 45" W, 617.47 feet to the Point of Beginning.
