TO AURORA AVENUE**

Dear Resident:

This letter is to inform you that the residents on S. OLIVE STREET have petitioned and qualified for permit parking. have petitioned and qualified for permit parking. **Installation and enforcement of "No Stopping Anytime except with Valid Permit" signs will begin the week of Monday, October 5, 2026.** A parking permit is required to park on the street but not in your driveway. Residents of single-family homes may purchase a maximum of three parking permits and are eligible for seventy-five single use guest passes per year. Residents of eligible multi-family properties may receive only one parking permit per unit.

A parking permit may be obtained in person or by mail. To obtain a parking permit in person, residents must bring photocopies of the information required given in the enclosed brochure along with \$93 for each parking permit (cash or checks payable to City of Santa Ana). If you would like to receive your permits by mail, please send the required information to the address below along with \$93 for each parking permit (checks only made payable to City of Santa Ana). Please include a brief note requesting a parking permit with your name and daytime telephone number in case we have any questions. We will process your request within five working days; however, residents are still responsible for having their permit before the enforcement week of Monday, October 5, 2026.
