



EXHIBIT A

(25 High Street, Unit 515 Portland, Maine)

A certain condominium unit located at and near 25 High Street in the City of Portland, County of Cumberland and State of Maine, being Unit 515 of a certain Condominium known as York & High Condominium, plus an undivided "Percentage Interest" in the Common Elements and its appurtenant Limited Common Elements, all as more particularly described and defined in the Declaration of Condominium for York & High Condominium dated October 30, 2017, created pursuant to the Maine Condominium Act, Chapter 31 of Title 33 of the Maine Revised Statutes, and recorded in the Cumberland County Registry of Deeds in Book 34428, Page 1, (the "Declaration").

The perimeter boundaries of said Unit 515-and the Common Elements are shown on the Plats and Plans (as hereinafter defined). The Plat is that certain Condominium Plat of York & High Condominium" prepared by Owen Haskell, Inc., dated October 23, 2017, and recorded in the Cumberland County Registry of Deeds in Plan Book 217, Page 470 (the "Plat"), and the "Condominium Plans of the York & High Condominium" prepared by Opechee Construction Company, dated July 6, 2017, consisting of Sheet 1 of 8 through Sheet 8 of 8, and recorded in the Cumberland County Registry of Deeds in Plan Book 217, Pages 471 to 478, inclusive (the "Plats and Plans").

The above-described Unit (including its undivided Percentage Interest in the Common Elements) is conveyed subject to the Declaration and the Plats and Plans, and the easements, restrictions, rights, benefits and terms thereof, and further SUBJECT to any other easements or restrictions of record. Terms not otherwise defined herein shall be given the same meaning ascribed to such terms in the Declaration.
