**TAXPAYER'S NOTICE**

Notice is hereby given that at least one half of your county, school and municipal property tax is due by November 6, 2024 and the remainder is due by May 7, 2025. Under State law, the ownership and valuation of all real estate and personal property subject to taxation shall be fixed as of April 1st. For this tax bill, that date is April 1, 2024. If you sold your real estate since April 1, 2024, it is your responsibility to forward this bill to the current property owner. After eight months and no later than one year from the date of commitment, a lien will be placed on all real estate for which taxes remain unpaid.

**INFORMATION**

This bill is for the current tax year, July 1, 2024 to June 30, 2025. Past due amounts are not included. As a result of the money our municipality receives from State Legislature through the State Revenue Sharing Program, Homestead Exemption Reimbursement and State Aid to Education, your property tax bill has ALREADY been reduced by 29%. Current outstanding bonded indebtedness is \$1,608,075.
