WARRANTY DEED

Maine Statutory Short Form

KNOW ALL MEN BY THESE PRESENTS, That **POTHIER HOLDINGS, LLC**, a Maine Limited Liability Company with a mailing address of 17 McKenney Drive, Biddeford, ME 04005, for consideration paid, grant to **POTHIER HOLDINGS, LLC**, a Maine Limited Liability Company with a mailing address of 17 McKenney Drive, Biddeford, ME 04005, with **WARRANTY COVENANTS**, the land in Biddeford in the County of York and State of Maine, and being 17 Willett Street in the present numbering thereof and described as follows:

A certain lot or parcel of land, together with the buildings thereon, situated on the northeasterly side of Willett Street in Biddeford, County of York and State of Maine, bounded and described as follows:

COMMENCING at a point, said point being the southwesterly corner of Lot #47 as shown on Plan of Sheltra Terrace prepared by Libby & Dow, Engineers, October 30, 1935 and recorded in the York County Registry of Deeds in Plan Book 11, Page 80

THENCE southeasterly by said Willett Street a distance of sixty-four (64) feet;

THENCE turning and running northeasterly a distance of one hundred (100') feet;

THENCE turning and running northwesterly a distance of fourteen (14) feet to the southeasterly corner of Lot No. 48, as shown on said plan;

THENCE continuing northwesterly a distance of fifty (50) feet to a point and the southeasterly corner of lot 47 on said plan;

THENCE turning and running southwesterly by the southeasterly sideline of Lot #47, as shown on said plan, a distance of one hundred (100) feet to the point of beginning;

Said parcel of land includes Lots #48 and fourteen (14') feet of Lot #49 situated on the southeasterly side of said Lot #48 and being contiguous to said Lot #48.

Being a portion of the premises contained in deed of Bonita Pothier to Pothier Holdings, LLC dated November 16, 2005 and recorded in the York County Registry of Deeds in Book 14702, Page 695.

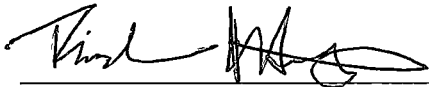
This deed is one of two deeds given to provide separate legal descriptions for 17 Willett Street and 20 Vincent Avenue in said Biddeford.
