

# Decatur Historic Resources Survey Neighborhood Summary

Date: September 1, 2009

Name: Glennwood Estates

Property Type: District

**Boundaries:** The proposed Glennwood Estates historic district is bordered roughly by Forkner Drive on the north, the Decatur Heights area to the east, East Ponce de Leon Avenue to the south and Glendale Avenue to the west.

Primary Dates of Development: 1930s and 1940s

Physical Description: Glennwood Estates is a residential neighborhood consisting of a main north-south street, Glendale Avenue, with two curvilinear cross streets, Mount Vernon Drive and Glenn Circle. Most of the development in the neighborhood occurred during the 1930s and 1940s, and the two prevailing house types found in Glennwood Estates are American Small houses and English cottages. Most of the houses follow no academic style, though there are many with excellent examples of the English Vernacular Revival style. The neighborhood has a strong sense of cohesiveness, with uniform rectangular lots, deep setbacks, slightly hilly terrain with mature trees, and curvilinear street patterns. For the most part, the neighborhood has retained its historic character but the construction of newer infill houses may threaten the historic fabric of the neighborhood.

Glennwood Estates contains 235 parcels (106.2 acres), of which 185 (78.7%) are currently contributing historic properties, 42 (17.9%) are non-contributing, and eight (3.4%) are vacant. The oldest houses in the neighborhood were built in 1928: 124 Glendale Avenue is a brick English cottage, and 216 Glendale Avenue is an English Vernacular Revival gabledwing cottage.


Reason for Significance (National Register of Historic Places Areas of Significance): Architecture, Community Planning and Development

**Description of Significance:** Glennwood Estates is significant in the area of <u>Architecture</u> because of the many excellent examples of American small houses and English cottages, many with strong elements of the English Vernacular Revival style. Glennwood Estates is also significant in the area of <u>Community Planning and Development</u> as an excellent example of an early planned neighborhood constructed in the early twentieth-century.



To truly appreciate where we live it is important know of its history. With help from Mr. Walter McCurdy and the DeKalb Historical Society, I investigated some history surrounding our neighborhood, Glenwood Estates. Due to a fire in 1842, which destroyed the courthouse, all land records were destroyed. Consequently there are more questions than answers about the earliest land ownership in the county.

The Creek Indians in the Indian Springs Treaty of 1821 ceded the lands that now are DeKalb County to the State of Georgia. The original DeKalb County was formed from Fayette to Henry Counties in 1822. DeKalb was divided into approximately 875 land lots, each containing 202.5 acres which were distributed via the Fourth Land Lottery. In 1853 DeKalb County was divided into two parts, the western portion becoming Fulton County.

Land Lot 247 of the 15th district encompasses our neighborhood including as far south as Sycamore Street, and as far North as Forkner. Tullie Choice, a former senator in the State of Georgia, is the first recorded owner of Land Lot 247 but faced a legal situation and the lot was sold 1842 in a Sheriff Foreclosure to Mr. Wooley. Wooley quickly turned around and sold it to John T. King, who then in 1847 sold the western portion of land lot 247 to Mr. Little and Mr. Adams. Mr. Little and Adams also bought parts of the land lots adjoining land lot 247, including parts of Land Lot 7, 8, & 49 of the 18th district. The lot exceeded 500 acres and extended from Sycamore up towards the North DeKalb Mall and the Hospital Area. They paid ten dollars an acre the highest recorded value paid for an acre up to that time.

The records then become unclear, but it seems that the Georgia Railroad Banking Company owned the western portion of Land Lot 247 and then later sold it to J.T. Glen in 1869. It was common after the civil war for Northern Land Speculators, often referred to as carpetbaggers, to purchase land in the South at low prices due poverty in South resulting from devaluation of Confederate money.

Mr. Glen?s kinfolk were mostly from New York. He owned a residence in Fulton and later built a house on Sycamore. Mr. Glen started developing his land early 1870s when he sold lots on Sycamore and Ponce de Leon. The Glen/Pierce house at 174 Sycamore was built in 1874 and descendents of J.T. Glen lived

there as late as the 1980s. In 1909 the land was passed onto his children in a corporation known as Glen Estates Incorporated. In 1913 Glen Estates sold a small portion of the land on Ponce de Leon to the City of Decatur for the Glenwood School built in 1914. This is the first recorded use of the word Glenwood.

In 1927 Glenwood Estates Corporation was formed to buy the land from Glen Estates Incorporated and develop the portion south of the creek (Glendale, Pinecrest, Glendale Cir.). Glenwood Estates Corporation was composed of land developers CE Patillo, C.G. McGay, F.O. Watkins, and F.H. Roberts. By 1939 most of the original development was completed so they began building on the area north of the creek (Forkner and Mount Vernon). Interestingly, the original development contained a restrictive convenant that preserved the north side of the creek as forest but the pressure to develop it prevailed. However, many of the original trees on the lots were preserved, especially along the creek, contributing to the amazing canopy we currently enjoy. It remains a possibility that the trees bordering the creek have never been cut, which would classify it as a very rare virgin forest. The north portion sold slowly due to its inauspicious debut during WWII, however soon after the war this section was quickly completed.

Mr. Walter McCurdy and his cousin Ann Hughs were able to give me some interesting background about life in the neighborhood in the early 1930s and 40s. Their fathers, Julius and Walter, moved into the neighborhood in 1939 at 124 Pinecrest and 119 Glendale Circle. Mr. McCurdy (Walter) bought his house for \$5700. As a young boy Walter Jr. used to have football games with other boys of the neighborhood on what is now Mount Vernon. Later when this area was developed, the boys from the south side of the creek would challenge those from the north side of the creek at the newly developed Glenlake Park. It turns out that the name of Glenlake came at the suggestion of Walter's father who thought the name should combine the names of the two neighborhoods it bordered. Glenwood and Great Lakes, hence Glenlake.

Mr. McCurdy also recalls an area of the neighborhood east of the lots on Glencircle that was commonly known as Dog Patch. The people living in this section were very poor and there was no electricity, floors, or running water.

Two interesting landmarks exist within land lot 247 on Forkner and Pinecrest. During the early 1900s, Forkner was actually Candler airfield and you will notice that pine trees planted on the former airfield land dominate this street. Pinecrest resides smack on top of Morse Hill which resided on the western portion of Land Lot 247 and was often referred to in the earlier deeds indicating land due east of Decatur.

This is just a small portion of the history of our neighborhood. There are many neighbors that lived here from the beginning and I hope to encourage a project with the Glenwood School to produce a more lengthy study of our wonderful neighborhood and neighbors.

There has been a friendly dispute about the spelling of Glenwood Estates. I looked over my research which consists of the land deeds, original filed plats, and notes from my interview of some elder residents, namely Mr. Walter McCurdy and Ann Hughs. John T. Glenn was the owner of the land that our neighborhood resides within since 1869. Either shortly before or after his death, around 1909, he or his kin transferred his land holdings to a New York (that is where he was from and most his family lived) corporation named, Glennwood Estate. He had already developed much of Sycamore St. going east from downtown Decatur before his death, including the Glenn house at 174 Sycamore (built in 1874). The corporation Glennwood Estate sold the portion that contains our neighborhood to the developers CE Patillo, CG McGay, and FO Watkins. On the original plat submitted in 1927 the spelling is Glennwood Estates, however, when a plat was submitted in 1937 to build the Mount Vernon Portion (Originally named Glendale Circle) it was spelled with one N or Glenwood Estates. Glendale has always been spelled with one N and Glenn Circle with two. I found some other info that I will share in our next newsletter.

Mr. McCurdy is quite certain that Mr. Patillo changed it to one "N" since he felt it was cumbersome with two "N"s. So which is it? I am partial to one "N" since that is how it is spelled on the last registered plat. My earlier assertion that it was another Glen, spelled with one N, that owned the land is completely wrong. There was a famous J.T. Glen in the history of Atlanta but he had nothing to do with the Decatur Glenns.





# Glennwood Estates' Triangle, A Symbol Of Neighborliness

The "Triangle" in Glennwood Estates has recently been land-scaped and replanted as a memorial tribute to Mrs. E.R. Ravenel by her daughter, Mrs. M. Lea Richards.

Mrs. Ravenel was a long time resident of the Glenndale area. A member of and one-time president of the Glenncrest Garden Club, she embodied in her life the club's purpose, "...the development of beauty and the furthering of neighborliness."

The Glenncrest Garden Club dates back to January 27, 1939,

when a group of residents of the recently subdivided Glenn Estate met to talk about forming a neighborhood association. The men organized a Civic Association and the women a garden club, which they named "Glenncrest" to incorporate the names of the three original streets in the subdivision. Glenndale Avenue, Glenn Circle, and Pinecrest Avenue. From its beginning, the club took on responsibility for the beautification and upkeep of the triangular plot at the intersection of Glenndale Avenue and Glenn Circle.

The Lea Richards Family has lived on Glenndale Avenue at the Glenn Circle intersection for 40 years, and during all this time, until his death on November 11, 1989, Mr. Richards saw to it that the flag was properly flown from the pole at the Triangle. The Garden Club and the Glennwood Estates Community as a whole regard the Triangle as a focal point and gathering place; they have much appreciation for Mrs. Richards' years of faithfully seeing that the flag was kept flying.
