### **Section 1:**

- Roofs of buildings are standing seam metal and presumed to be original, but age is unknown.
- Existing septic systems function, but are not up to current LCRA code and may require modification for a continuing use permit.
- Property is all electric – there is no propane or natural gas.
- Corix is the water provider and there are approximately +/- 15 meters on the property.
- Some structures are believed to be built prior to 1978. Seller has no knowledge of lead based paint present on the property.

### **Section 2:**

- There is a plumbing leak on a water supply line on the west side of the property. Leak repair is progress.
- There was freeze damage to the plumbing in the laundry building in 2022. Plumbing was repaired and no issues since that time.

### **Section 3:**

- To seller's knowledge, asbestos siding is present on the exterior of 4 or 5 cottages.
- The main Corix water line that runs down Hwy 29 slightly encroaches on the property line along the highway frontage at the west end of the property near the lake.
- There was a flashing that leaked on the roof of the clubhouse during the heavy rain over July 4, 2025. The leak was repaired and a 3' x 3' area of sheetrock was replaced in the ceiling.
- Prior to our ownership, there was an equipment fire inside the metal storage building by the cove where the lawnmowers and equipment are kept. Evidence of the fire is visible on the inside of the metal building.
- There was a Texaco gas station on the property in the 1990's along the highway. The underground tanks were removed and remediated in 2007 by previous owners. We have the inspection documents and approvals from TCEQ for the removal available for review.

### **Section 4:**

- A vehicle on highway 29 swerved to avoid a deer and hit the brick fence recently, damaging approximately a 15' section of fence west of the lighthouse entrance. The driver's insurance company paid a claim and the fence repair is in progress. No claim was filed on our insurance.

### **Section 5:**

- Per the ALTA survey, the top of the bulkhead wall is at the 1020' elevation which is even with the top of the Buchanan Dam and the property is outside the floodplain.
