Previous Other Structural Repairs – 1.) One north facing window in a bedroom leaked with very hard rain storms. Inspected and repaired by licensed professional from "TexFix" on 7/10/2024 2.) Heavy rain caused sediment build up behind the garage allowing water to seep into the garage. Water was not enough to rot the framing or affect the integrity of the garage. Licensed professional tested and found minimal mold counts. Sheetrock was removed, area allowed to dry, sprayed with anti-mold bleach solution and sheetrock replaced new, taped, floated, painted. A French drain installed in June 2022 by a licensed contractor to deter future rain seepage into the garage, diverting water around the garage.

Improper Drainage – When house was built, drainage away from the garage was not properly engineered. Over time sediment built up behind the garage. In June 2022 a French drain was installed by a licensed contractor to divert water around the garage.

Wood Rot – Front of the house fascia board decay due to compromised gutter. Gutters remove and board recently replaced in May 2024 by a licensed contractor.

Previous treatment for termites or WDI – Previous owners treated for termite infestation residing in the back wall of the garage. When purchased, there was no active infestation upon inspection, and none has been noted since.

Previous termite or WDI damage repaired – Previous owners treated a termite infestation in the back wall of the garage, yet did not evaluate for wood damage. Since purchase, the garage has had all known structurally compromised 2x4 framing due to termites replaced with new wood and treated with termite deterrent to help prevent possible future infestations.
