(Foundation/Slabs) Foundation work completed in August 2019 in front of house with 11 piers. Additional 17 piers added around the house in Jan 2025. Realtor has copies of the paperwork. Silicone injected into the patio and sidewalks. After house settled, 10 hairline cracked tiles replaced in kitchen and drywall cracks repaired and repainted inside of house.

A drywall crack remains in the garage as it was full of household goods when the interior repairs were completed.

(Sidewalks) Sidewalk is slightly uneven due to foundation issues, however the foundation issues have been repaired.

(Windows) The seal is broken on two windows in the enclosed patio.

Inspected in January 2026 Paperwork has been provided to the realtor.

(Settling) Foundation repairs as noted above. Cracks in the house drywall were repaired within 12 months, per Groundworks instructions, to allow for settling. Inspection conducted Jan 2026, provided documents to realtor.

(Soil Movement) Subdivision built over expansive clay soils. Normal movement for the subdivision.
