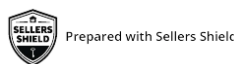

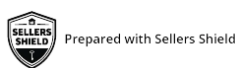

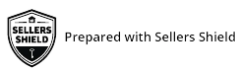

Brokers are aware of their responsibility to ensure compliance.
