
Trail Rules, Safety, & Etiquette

1. Trail open during daylight hours only, except on Durham urban portion.
2. No motorized vehicles.
3. No alcohol.
4. Dogs must be on 6' or shorter leash. Please remove dog waste from trail surface and discard in refuse containers in the parking lots.
5. ATT users should observe standard trail usage by keeping to the right side of the trail and generally not walking or riding more than two abreast. On the Durham section and on the paved sections in Chatham, please observe the dashed center line markings. On the granite screenings section in Chatham and on all sections in Wake County, please try to use only the right hand side of the trail. Cyclists should shift to single file when overtaking or meeting other users.
6. When overtaking a horse, cyclist, or hiker from behind, please give an audible warning of your approach. Ex: "Passing on your left". Thank them after passing.
7. Riders of bicycles & other wheeled vehicles should slow down when approaching or passing pedestrians and horses.
8. Hikers should yield to horses.
9. Let horses cross bridge or exit tunnel before you enter.
10. Access to drinking water is limited. A water fountain furnished by the Triangle Rails-to-Trails Conservancy operates from late March to late November at the Pittard Sears parking area in Chatham County. Seasonal water may also be found at Wimberly Road and at the New Hope Church Road trailhead in Wake County, and at Solite Park and Herndon Park in Durham County.
11. In emergencies, dial 911.
12. Please report any unsafe conditions to: Durham - (919) 560-4355; Chatham - (919) 462-3863; Wake - (919) 387-2117.
13. This is a shared use trail. Please be courteous and patient with other trail users so that everyone may enjoy the trail.
14. Please do not leave trash on the trail or toss it off to the side. Trail staff are not expected to pick up litter.

Connection to White Oak Greenway: This hard surface trail runs 7.3 miles northeast from just north of the Wimberly Road Parking Area to Fred Bond Park on High House Road. From the ATT, this greenway uses short tunnels as it crosses Green Level Church Rd, NC Highway 55, and SW Cary Pkwy. At-grade crossings are required at Jenks-Carpenter Road, MacArthur Drive and Davis Drive. At Bond Park there are year-round restroom facilities, seasonal water fountains, and a connection to the Black Creek Greenway.





