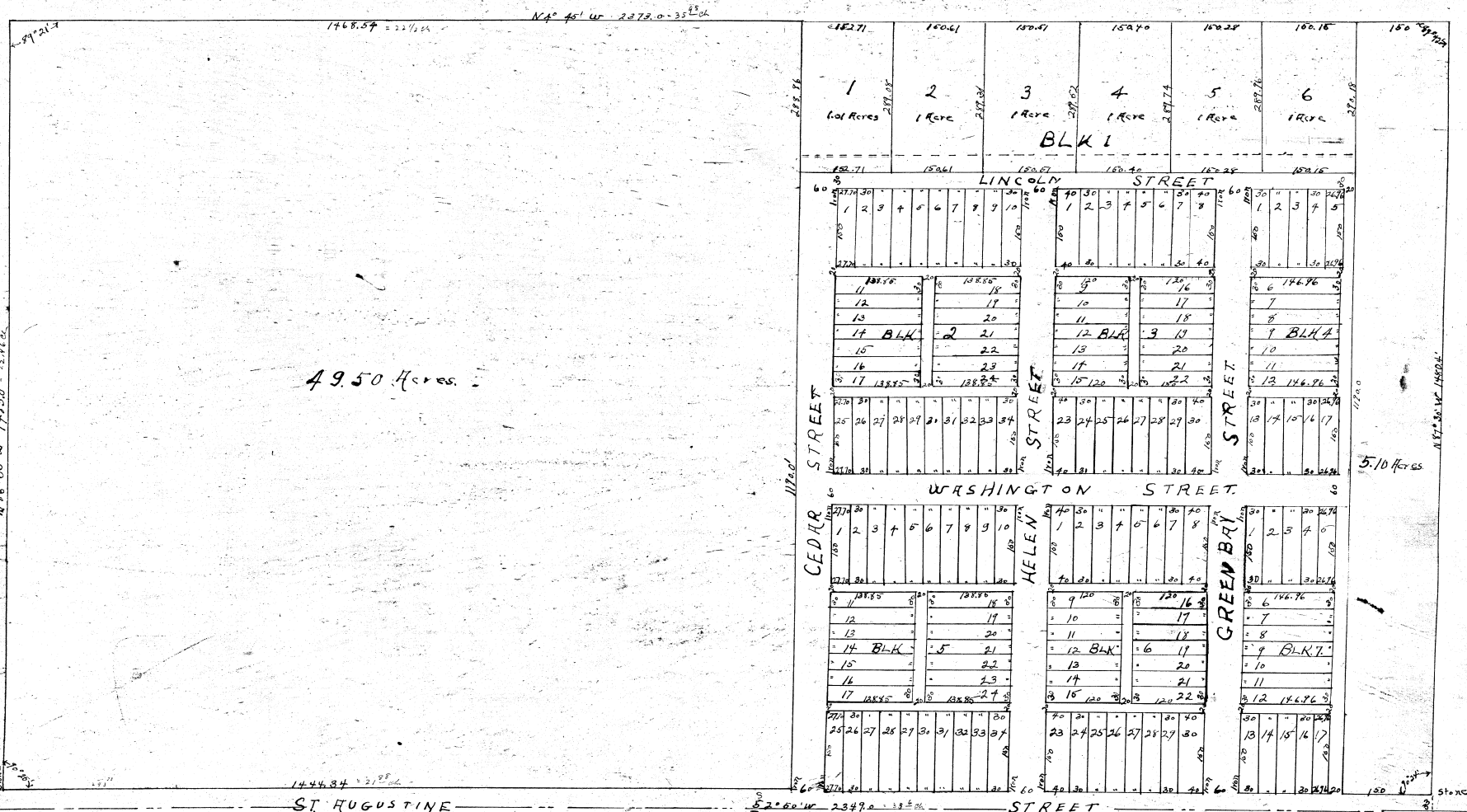


# BAKSALERSKIS ADDITION
