- 3. Retroactive; Five Year Extension; Automatic Thereafter. The Restrictions, as extended, and when recorded in the Real Property Records of Kerr County, Texas, shall be effective retroactively to December 31, 1997, or the date on which any prior restrictions for any Site in Royal Oaks expired, whichever is earlier. The Restrictions by mutual agreement are hereby extended from December 31, 1997 for a term of 5 additional years until January 1, 2003, after which time the Restrictions shall be automatically extended for successive additional terms of 5 years each for an indefinite period of time, unless and until a written instrument, abolishing in whole or in part or amending all or any part of the Restrictions, and signed by at least 80% of the then Site Owners, has been recorded at least 90 days prior to the effective date of such instrument. Any existing structure, residence, or outbuilding which now violates the set-back requirements or structural requirements of the Restrictions is hereby agreed to be in conformity to the Restrictions and shall not be deemed in violation of such Restrictions. However, all future new construction or repairs or remodeling begun after December 31, 1997 shall comply with the Restrictions in effect at the time such new construction or future repairs and remodeling is begun.
- 6. Enforceability; Attorney's Fees. Any Site Owner may enforce the Restrictions by seeking injunctive relief against the continuation of any violation of the Restrictions that occurs or is threatened to occur. In event a violation of Restrictions is judicially determined in a court of law to exist or is about to occur, the Site Owner whose actions are in violation of the Restrictions shall be liable to all other Site Owners for all attorneys' fees, costs of court, expenses, and damages incurred by them or by any one of them as a result of the violating Site Owner's actions that are in violations of the Restrictions. Injunctive relief may be granted without the necessity of the complaining Site Owner being required to file a bond or security of any type as a prerequisite to obtaining injunctive or other relief.
