

According to Bloomberg, over the last 5 years, the Jamaican stock market has advanced by 233 percent, the most in the world, with the Vietnam Ho Chi Minh Stock index coming second at 86 percent, both turning out even better than the S&P 500 that only advanced by 73 percent over the same time period.
