# THE DETAILS

## PROPERTY OWNER MEMBERSHIPS (POM)

---

Property Owner Membership (POM), is a unique category of membership reserved for lot purchasers in Amarra Drive, Calera Court, Calera Drive, Escala, Governors Hill, Mirador, Wimberly Lane, Verano Drive, and Woods III. The POM category provides social access to club amenities including:

Private Clubhouses | Dining | Social Activities | Pools | Fitness Center & Group Classes

Full details regarding the POM requirements are outlined in the Restrictive Covenant of the Covenants, Conditions, and Restrictions that run with your property. This set of documents would have been provided to you before closing on your property or you may contact the Homeowners Association for your area.

After closing on their property, lot/homeowners should schedule an appointment with the club to establish their membership and become familiar with club life. A copy of your closing documents is needed to complete your application establishing your member charge account. Property owner applicants must abide by all aspects of the application process as outlined in the Club Bylaws, including the required two member sponsors. Dues will be charged to the member's account beginning after the closing date. Monthly dues for 2025 are \$420.00 plus tax.

The POM is available only to the property owner and may not be transferred, sold, conveyed, or used by anyone other than the current property owner. If an active POM sells their lot but wishes to continue as a club member, they must pay the current initiation fee and dues for the membership, subject to category availability. Property Owner Members may request an upgrade to a racquet or golf membership if vacancies exist. The payment of an initiation fee and higher monthly dues will apply.
